

BOARD RESOLUTION NO. 2 0 1 8 - 0 1 4

Approving the FY2018 Corporate Operating Budget and FY2018 Capital Expenditure Budget of the Development Academy of the Philippines (DAP)

WHEREAS, the DAP Board of Trustees, through Board Resolution No. 2017-10, approved the FY2018 Indicative Corporate Operating Budget and the FY2018 Indicative Capital Expenditure Budget;

WHEREAS, the amounts as earlier proposed in the FY2018 Indicative Corporate Operating Budget and the FY2018 Indicative Capital Expenditure Budget of the above mentioned Board Resolution are less than the currently proposed FY2018 Corporate Operating Budget and FY2018 Capital Expenditure Budget due to the inclusion of another P326.25-Million budget for the DAP Conference Center-Tagaytay Expansion Plan;

WHEREAS, there is an urgent need for the DAP to have a Board-approved FY2018 Corporate Operating Budget based on the submission by DAP Management of Total Sources of Funds in the amount of Php1,670.543 Million and Total Uses of Funds in the amount of Php1,650.065 Million, resulting in Excess Funds in the amount of 20.478 Million; and,

WHEREAS, DAP has to comply with the reportorial requirements of the Department of Budget and Management (DBM) for the purposes of fund release and implementation of DAP's major government projects.

NOW, THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED, that the FY2018 Corporate Operating Budget and the FY2018 Capital Expenditure as well as the Research and Development Budget, the details of which are shown in the "Summary of Corporate Operating Budget for FY2018" (ANNEX A), are hereby approved.

RESOLVED FURTHER, that any adjustment on the attached Budget shall require the prior approval of the Board.
